

Copyright License and Release Agreement

For Submission to The Letter-Lounge Booklet

I, the undersigned Submitter, hereby grant The Letter-Lounge the non-exclusive royalty-free, perpetual, fully paid-up license to use, copy, reproduce, publish and distribute my submitted letter(s) and/or content in print, digital and all other formats now known or later developed for inclusion in a collective booklet and related publications. This includes the right of The Letter-Lounge to sublicense, assign and use the materials for promotion and marketing. I waive moral rights in my work provided, however, that The Letter-Lounge may not edit or use my Letters for scandalous, discriminatory, defamatory, libelous, harassing, pornographic or illegal purposes. I waive rights to attribution but I retain ownership of the original content but give The Letter-Lounge permission to use, edit (for length or clarity), and publish my Letter(s) for promotional or commercial purposes.

I confirm that the submitted Letter(s) and content are my original work and do not infringe on the intellectual property or rights of any third party. If I have quoted a third party work, I have properly attributed such to its author and use it only for fair use purposes.

Content Standards and Eligibility.

The Submitter represents, warrants, and agrees that the submitted Letter(s) and any accompanying materials:

(a) do not contain content that is unlawful, obscene, pornographic, sexually explicit, threatening, hateful, discriminatory, or otherwise objectionable;

(b) do not contain content that is violent, promotes violence, glorifies criminal activity, encourages self-harm, or advocates unlawful conduct;

(c) are not defamatory, libelous, false, misleading, or otherwise injurious to the reputation of any individual, business, organization, or other entity;

(d) do not harass, bully, intimidate, stalk, abuse, exploit, or invade the privacy or publicity rights of any person;

(e) do not contain material that infringes or misappropriates any copyright, trademark, trade secret, right of publicity, privacy right, or other intellectual property or proprietary right of any third party;

(f) do not contain confidential information of any third party without authorization; and

(g) comply with all applicable laws, regulations, and community standards.

The Letter-Lounge reserves the sole and absolute right, in its discretion, to reject, remove, edit, decline to publish, or discontinue publication of any submission that it reasonably

believes violates this Agreement or is otherwise inconsistent with the mission, values, or editorial standards of The Letter-Lounge.

In the event of any actual or threatened default in, or breach of, any of the terms, conditions and provisions of this Agreement, the Party who is or is to be thereby aggrieved shall have the right to specific performance and injunctive or other equitable relief of its rights under this Agreement, in addition to any and all other rights and remedies at law or in equity, and all such rights and remedies shall be cumulative.

This Agreement will commence upon submission of the letter and this release and continue until either party provides written notice of termination to the other party with a 30 days' written notice. Each Party shall comply with all Applicable Laws in performing its obligations or exercising its rights pursuant to this Agreement.
